### GENERAL CONDITIONS OF RESERVATION AND RENTAL

- 1- Reservations are made only using this contract.
- 2- The signatory of the contract **must be major**.
- 3- The rental is personal and may not be under rented.
- 4- the booking will be final only after payment of 30% of the amount of the stay as a deposit, + the booking fees of an amount of € 19 and the acceptance of the lessor. The check will be on the agenda of the SAS « Le Grand Jardin »
- 5- **The balance is payable in full on arrival or can be addressed 1 month or 15 days prior to arrival to facilitate the terms of home. (No check the day of arrival)**
- 6- A single car is included in the rental rate, any additional car will be counted at the rate of the campsite in force and subject to space available.
- 7- The rental must be occupied by the number of people indicated on the booking contract and corresponding equipment of housing. "Composition of family" written on the rental agreement is contractual, and cannot so be changed without agreement wrote of the booking service. Any changes must be reported at least 1 month prior to arrival subject to acceptance of the lessor. Otherwise, the office reserves the right to deny access to the mobile home. It is forbidden to exceed the indicated capacity
- 8- Any misrepresentation will make the contract lapsed, the deposit and booking fees will remain acquired by the lessor; all of the information on this contract will be used for the invoice.
- 9- The lessor reserves the right to refuse a rental.
- 10- Rental is not occupied within 24 hours of the start of your contract without any notice from you.
- 11- The acceptance of rent by the customer is subject to respect for the rules of the campsite.
- 12- I am informed that pictures can be taken in the campsite for advertising purposes.
- 13- Pets are allowed subject to be kept on a leash at all times, not to cause any disturbance and have an up-to-date vaccination book.
- 14- The management reserves the right to expel any person not complying with the rules inside the campsite or causing nuisance to others and to appeal to the forces of the order if necessary
- 15- In order to avoid any misunderstanding, we ask you to notify us of any delay or late arrival. We reserve the 14 - the liability of the owner or the management of the campsite cannot in no case be engaged in case of loss, theft or damage of any kind, during or after a stay. The tenant is responsible for any damages that may arise in its fact. It has the obligation to be insured against risks such as theft, fire, water damage,... by a contract of insurance type resort to these risks.
- 16- In low season, only some services will work.
- 17- No refund will be made for cause cancellation, late arrival, early departure or day of absence, whatever the reason. Attached insurance optional cancellation but we strongly recommend to subscribe.

- Loc week : arrival 15 h to 17 h 30 (7 pm summer) and departure 9: 00 to 11: 00 (9: 00 to 12: 00 summer); Loc weekend: arrival Friday 16 pm to 5.30 pm and 10: 00 to 12: 00 departure or arrival Saturday 11 a.m. to 12: 00 and 14: 00 to 16:30 departure
- A deposit of € 390, in 2 separate checks, one of €300 for damage and one of €90 for the household, will be requested upon arrival at the reception, and returned within 10 days after departure, minus any missing or damage and/or time of cleaning. The mobil-home/cottage must be left clean. A sum of €90 will be charged per hour of household if the mobile home State requires the intervention of the cleaning staff. The manager being one judge.
- These rates include: gas, electricity, TV, barbecue, pool covered and heated and heating in the mobile home if necessary. Tourist tax not included (2019: 0€ 65) per day and per person over 18.
